**RESOLUTION 2017-02**

A RESOLUTION OF THE BOARD OF SUPERVISORS  
OF MONROE TOWNSHIP, CUMBERLAND COUNTY,  
PENNSYLVANIA, ESTABLISHING A SCHEDULE OF FEES.

WHEREAS, the Supervisors of Monroe Township are authorized by the Second Class Township Code and by the Pennsylvania Municipalities Planning Code to prescribe reasonable fees; and

WHEREAS, the Supervisors of Monroe Township wish to incorporate in one Resolution all fees; and

WHEREAS, the fee schedule shall be effective immediately after the date of this Resolution; and

WHEREAS, all fees to be made payable to MONROE TOWNSHIP and collected by the Township office and staff. The sewage fees are collected by the Sewage Enforcement Officer and turned over to the Township on a regular basis; and

WHEREAS, any Resolution or part of Resolutions conflicting with the terms of this Resolution, be and the same, are hereby repealed to the extent of such conflict.

NOW, THEREFORE, be it resolved by the Board of Supervisors of Monroe Township, Cumberland County, Pennsylvania, that the following be established as the Schedule of Fees:

*Set the copy price at \$.25 per page for copy made when staff time used is under 15 minutes. When a file request requires more than 15 minutes of staff time there will be a charge of \$15/per hour for all time in excess of 15 minutes, plus \$.25 per copy. Where Consultants are used to perform the work requested, the Consultant's hourly rate shall be used.

#### Subdivision Fee

1. The filing fee and the actual cost of engineering services is required for preliminary plans and final plans, as specified in the Monroe Township Subdivision and Land Development Ordinance. Application shall not be considered complete and will not be accepted until the filing fee and deposit for engineering services is paid.
2. Filing fee (Preliminary, Final, Land Development) (Res. 2003-6) \$ 500.00
3. Initial deposit for the actual cost of engineering services \$2,000.00
4. The re-submission of a previously rejected plan or the re-submission of a plan not properly recorded shall be deemed a new submission subject to the fees, deposits and costs provided hereunder unless waived by the Board of Supervisors.

5.	Where a preliminary-final subdivision plan is authorized by the subdivision and Land Development Ordinance of Monroe Township, the Board of Supervisors, in its discretion, can authorize the payment of one application fee only.
